- ✔ Increased competition from Corporate Chains and bigger Hospitals.
- ✔ Non - availability of Full Time Doctors in various clinical specialties and Super Specialty Branches.
- ✔ Non - availability of trained nursing and paramedical staff affects patient care.
- ✔ The Non -availability of Clinical Specialists and other staff leads to unnecessary referral of patients to corporate hospitals in metro cities.
- ✔ Increased burden of Medico legal cases and litigations.
- ✔ Increase in compliance burden due to Clinical establishment Act and tightening regulatory framework.
- ✔ Increased Compliance costs add to further stress on profit margins of smaller hospitals and Nursing Homes.
- ✔ Regulatory push by Govt to curb the pricing of drugs, medical devices and medical procedures, further reduces profit margins of healthcare providers.
- ✔ Schemes Like Ayushman Bharat have improved access to health care but low pricing has further diminished profit margins of hospitals.
- ✔ Higher cost of procurement due to lack of economies of scale in standalone hospitals.
- ✔ Difficulties in Patient's Medical Records and other related data.
- ✔ High attrition rate of patients due to gaps in follow up care.
- ✔ Lack of resources to engage patients through digital marketing and improve market outreach.
- ✔ High expectations of patient population driven by "Dr Google"!
